## REGULATIONS

### GOALS AND OBJECTIVES:

- To popularize Karate-Do as a sport;
- To promote the sport among young people.

### ORGANIZER

Jelgava karate club "VITUS" (reģ. Nr. 40008203257) in collaboration with the Latvian Karate Federation (LKF) (reģ. Nr. 40008024026), with support from Jelgava Centre of Sports Service and championship organizer Vitālijs Mišins (phone: +371 29585311, e-mail: [vitalymishin@gmail.com](mailto:vitalymishin@gmail.com)).

### PLACE AND DATE

**June 1th 2025, from 10.00 in Jelgava Sports Hall** (Matera street 44a, Jelgava, Latvia, LV-3001). Registration and payment of fees for participation from 9.00 a.m. at the event site. All participants need to have an ID and a karate identity document showing age and kyu. From 9.30 to 10.00 team representative and judge briefing.

### JUDGES

An LKF panel of judges. Main judge – Santa Drozdova

**The consideration of protest will be 100 EUR and to file a grievance you must have video footage.**

### PARTICIPATION IN THE CHAMPIONSHIP

**Athletes from 6 years of age may participate in the championship.** Registration limit for participants – the first 300 applicants. **Participation is allowed only in your own age group.** Allowable overweight: 200 grams for males, 500 grams for females. If the athlete does not correspond to the category that was presented when submitting the application, the athlete is disqualified and may not participate in further competitions. In this case, the participation fee is not returned! His coach is responsible for the athlete's timely exit to the tatami. The team representative and/or coach is responsible for the participant's compliance with a specific age and weight category, as well as for the preparation of a specific athlete for the competition.

### All participants must wear kimono (Karate Gi)!

Adult participants are responsible for insurance and their own health during the competition. If the participant is a minor, the responsibility is assumed by the parents or guardians. The team representative and/or coach is responsible for the participant's compliance with a specific age category, as well as for the preparation of a specific athlete for the competition. It is the duty of the team representative to introduce each athlete of the team to the conditions of this REGULATION.

### FEE

EUR 35 per category. No discounts for participation in more than one category. The participation fee can be paid by transfer to the account number LV42HABA0551036971005 AS Swedbank, HABALV22 of the association "Jelgava karate club "VITUS"" (reg. no. 40008203257).

## CATEGORIES

The competition will be held according to the "Olympic" system with full repechage. **The organizer has the right to change the categories.**

**Terms of KATA.** The size of the arena is 8 m x 8 m. Three referees. "Olympic" system with full repechage. Contestants are allowed to perform any kata from the WKF list + Taikyoku. Athletes up to 9 years old must know at least 1 KATA; from 10 to 11 years old – perform at least 2 different KATA, from 12 to 13 years old – at least 3 different KATA. For athletes over 14 years old Kata competitions are held according to WKF rules (flags' system). Athletes from 6 to 11 years old perform KATA simultaneously. Athletes perform KATA with belts that match the color of the athlete in that bout (AKA or AO). In all KATA categories for athletes from 10 years of age failure to observe the rules related to bowing is subject to disqualification (the number of bows must comply with the WKF rules).

**Terms of KUMITE.** The size of the arena is 8 m x 8 m. Three referees. **The duration of the fight for children up to 9 years old – 1 min., from 10 to 12 years old – 1.5 min, from 13 years – WKF rules. The fight takes place until an athlete has an 8- point lead.** "Olympic" system with full repechage. Participants' equipment: hand gloves and leg protectors for the foot and lower leg according to the WKF model, dental protectors are mandatory. Protective vests are mandatory for all athletes! Breast protector for girls – optional. In boys' categories, hip (groin) guard (bandage) – mandatory from 12 years, to 11 years – optional. Breast protector for girls to 13 years – optional, starting with 14 years – mandatory. **Athletes, their coaches and parents are independently responsible for any injuries obtained as a result of not using the equipment! The organizers of the championship do not provide the participants with the necessary equipment.** Belts, gloves and leg protectors for AO in blue, for AKA in red.

**The Main Judge and/or Organizer of the competition shall decide on issues that arise during the competition and are not covered by these regulations.**

## PRIZES

Awarding of the winners and prizewinners is conducted in parallel to the tournament. 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places will be presented with cups. One 3<sup>rd</sup> place in all categories! The three best clubs in the overall ranking will be awarded cups.
